**The following information refers to the Requirements Table**

(\*1) Both **Reiki Practitioner** and **Reiki Master/Teacher** categories require insurance coverage. If you do not already hold *Public Liability & Professional Indemnity Insurance*, you will need to complete your membership application and receive your Reiki Australia membership number before applying for insurance. Insurance is available to Australian residents only.

(\*2) The NSW Code of Conduct for Unregistered Health Practitioners requires all NSW practitioners to hold a Senior First Aid certificate. It is expected that this code will be adopted nationally. Reiki Australia highly recommends all Reiki practitioners consider the benefits of completing a course in Senior First Aid.

(\*3) **Reiki Practitioner** member category requires you to provide a log of 10 Reiki treatment sessions over your **first year** of membership.
